NON-RESIDENTIAL SERVICES INCLUDE INDIVIDUAL AND GROUP COUNSELING FOR ADULTS AND CHILDREN, AS WELL AS CHILD CARE. THROUGH NON-JUDGMENTAL SUPPORTIVE SERVICES, WE AIM TO CREATE A SAFE ENVIRONMENT WHERE WE CAN HELP OUR CLIENTS EMPOWER THEMSELVES TO MAKE HEALTHY CHOICES THAT WILL BENEFIT THE EMOTIONAL AND PHYSICAL WELL-BEING OF THEMSELVES AND THEIR CHILDREN.
